Over the years, Mance Vaught was joined by Donald Wright, Paul Bond, and Bill Crow and was later incorporated in 1972, keeping their name as Vaught, Wright & Bond, Inc.

In 1982, Leonard Stroud joined the team as a producer and added life and health insurance to the agency's offerings. In October 1990, he acquired all of the corporate stock and was appointed as the sole Director. Bruce Dezzani started as a Commercial Lines and Personal Lines Producer in September 2000 after spending over a decade in business management. He then rose to the position of General Manager and bought 50% of the company's shares in 2005. In August 2015, he became the only stakeholder.

Over the past two decades, the company has rapidly expanded outside of El Dorado County while remaining a generalist and writing mostly local risks. The agency continues to be deeply committed to the local community and its concerns despite the geographic expansion.

As part of the acquisition, Inszone Insurance will retain Vaught, Wright & Bond Insurance employees, as well as the current location in Placerville, CA.

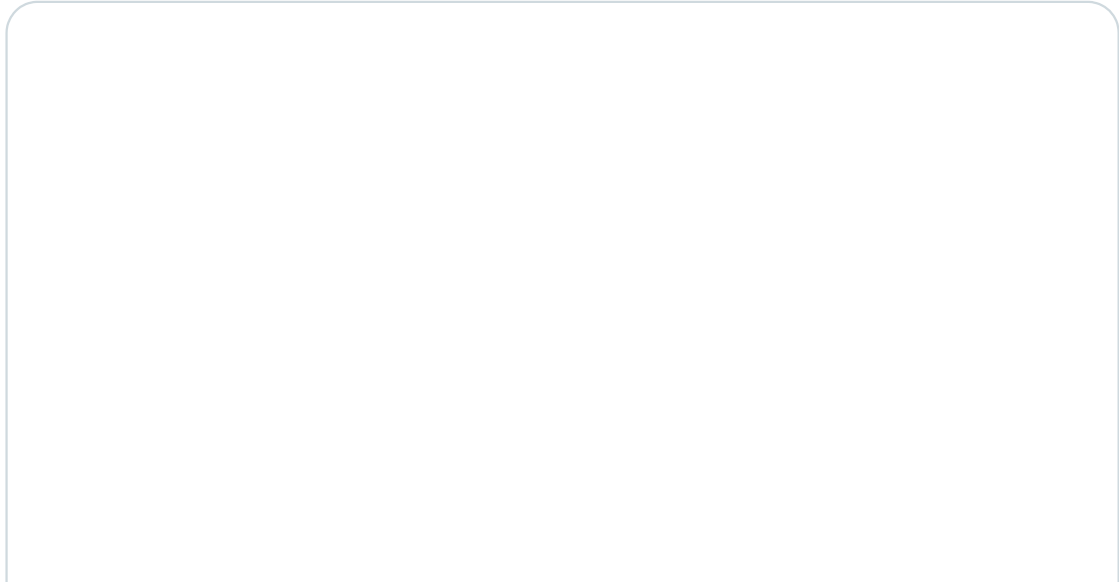

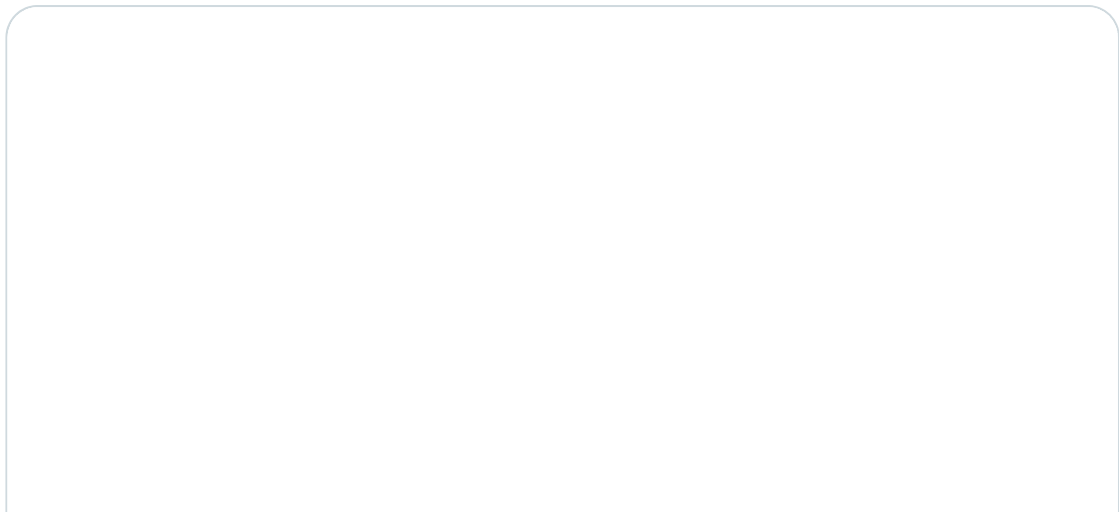
